

AFFORDABLE HOUSING OPPORTUNITY REOPENING WAITING LIST

Mission Park will be accepting applications for multiple bedroom sizes **1, 1HP, 2, 2HP, 3- and 4-bedroom** family housing units under the HUD Section 8 and Low Income Housing Tax Credit Programs. Eligible applicants will be placed on an existing waiting list by random order via a lottery, *not* by the order in which the completed application is received. **There are no units available at this time.**

Applications will be accepted between **Monday, June 10th, 2019 at 9:30 a.m. through Friday, June 28th, 2019 at 5:00 p.m.**

Applications received after this date will not be accepted. Please note that office hours for **Mission Park** are: **Monday 9:30 am to 6:00 pm, Tuesday through Friday 8:30 am to 5:00 pm.**

If you send your application by mail, the application must be postmarked with a date no later than June 28th, 2019.

Applications submitted in person at Mission Park, must be received by Friday, June 28th, 2019 at 5:00 p.m.

Incomplete applications will not be considered.
